

Guidelines for Authors valid as of issue nr. 25 (2025)

General stylesheet

Italics are used for words in languages different from the one in which the article is written, to draw attention to key terms (sparingly), for titles of books and works mentioned in the text. Italics should not be used for Greek words and quotations. Please avoid underlined and bold.

Quotations from classical and modern texts should appear in low double quotation marks (*e.g.* «arma virumque cano»: in this case, for Latin, the roundel may be retained) or, if longer than three lines, be placed in blocks of text in smaller body preceded and followed by a blank line. For additional quotations within quotations, high double quotation marks (“...”) and superscripts (‘...’) will be used. Punctuation marks follow the quotation marks. Omissions within a quotation should be indicated with three dots in square brackets: [...].

Footnote numbers should always be inserted after the punctuation mark.

Abbreviations for ancient and medieval authors and their works

Abbreviations for Greek authors' names and titles of works should preferably follow those listed in H. G. Liddell - R. Scott - H. Stuart Jones, *A Greek-English Lexicon*. For Greek Christian authors not included in the LSJ follow the *Patristic Greek Lexicon* ed. by G. W. H. Lampe.

Abbreviations for Latin authors' names and titles of works should preferably follow those listed in the *Thesaurus Linguae Latinae*.

Biblical references should be abbreviated according to the current conventions of the language in which the article is written (please refer to the prospect in «Biblica» 70, 1989, 581-582), and should be given in the following format:

Gn 1, 2; 2 Cor 2, 3-4.

Dictionary entry references should be given in the following format:

LSJ *s.v.* ἐιμί, III.2; Lampe *s.v.* ὁρθόδοξος, A2; LBG *s.v.* στηλογραφέω.

Bibliographical references

Manuscripts

It is preferable to provide an extended citation (city and library name in the original language, fund, shelf mark, *Diktyon* number) when citing a manuscript for the first

time, and then to use abbreviated version; it is also possible to use the usual acronymic abbreviations for major libraries.

Firenze, Biblioteca Medicea Laurenziana [or: BML], San Marco 303 (*Diktyon* 16881); thereafter: Laur. San Marco 303.

Paris, Bibliothèque nationale de France [or: BnF], Supplément grec 1233 (*Diktyon* 53897); thereafter: Par. suppl. gr. 1233
